
Our workshops engage participants in the proactive work of your governing body and good governance, emphasizing: Legal and Fiduciary obligations; Your relationship with the members; Your relationship with staff; and How to limit and avoid liability.

The workshop includes handouts and breakout sessions as well as examples from real situations that we have encountered. Learning outcomes include, but are not limited to, the following:, An understanding of key Governance functions, including the planning process; An introduction to the process and structure of governance including your authority and decision making powers; An understanding of Conflict of Interest / quorum / etc. in various meeting situations; An introduction to what a respectful workplace is, and how to deal with bullying and harassment; An example of governance policies and procedures for the Board and the Top Manager.

Areas include:

An introduction to, and overview of, the roles and responsibilities of Board as a whole; the roles and responsibilities of the Chair; The roles and responsibilities of Directors; The roles, responsibilities and desirable qualifications of the organization's Top Manager; Working towards a respectful workplace; How to create and manage effective committees; Running effective meetings; The Planning Process. Sa'hetxw Consulting walks you through an interactive two-day workshop that focuses on "good governance" practices. Our workshop helps you understand your roles and responsibilities as the Board of Directors including strategic ways you can help your organization set a strong governance foundation for years to come. The *Ts'idāne á' nezen?*: Youth for Dignity in Relationships project is a phase 2 of the successful Youth for Safety that ran at Watson Lake Secondary School from 2015-2017. This new project is being developed under the leadership of Liard Aboriginal Women's Society (LAWS) in collaboration with community leaders and organizations, and aims to address gender-based and relationship violence among Youth in Watson Lake and the Kaska Nations.

The project is also an important opportunity to revitalize cultural identities, connect with Elders, and support the continuation of Kaska culture and traditions- a future in which Liard Youth have a role in ensuring a safe and resilient Kaska community.
