Indian Residential Schools Personal Credits Information

Personal Credits can be used for formal education (college, university, trades, access programs etc.), and ALSO language and culture projects.

This can include traditional knowledge courses taught by elders, culture camps, healing, and on-the-land activities including:

- hunting, fishing, trapping, tanning, canoeing, camping
- harvesting and preparing traditional foods and medicines
- artistic and cultural expression-beadwork, sewing, carving, painting, dancing, storytelling, traditional games, etc.
- traditional laws and values roles, rites of passage, governance.

Personal Credits may be pooled by others that have received CEP to participate in Group Educational Services including those aimed at the preservation, reclamation, development or understanding of First Nations identities, histories, cultures or languages.

Educational programs or services include but are not limited to those provided by universities, colleges, trade or training schools or which relate to literacy or trades, as well as programs and services which relate to the preservation, reclamation, development or understanding of First Nations history, cultures or languages.

Important Deadlines: Personal Credits Acknowledgement Form Submission Date: October 31st 2014. Educational Entity or Group must have the paperwork to Crawford no later then December 1st 2014. The Educational Entity must have the funds spent on your behalf no later then April 15th, 2015. (Please note that when mailing your forms, they must be postdated no later then the deadline or they will not be accepted.)

You can transfer the credits to any of the educational institutions across Canada, Daylu Dena Council, Liard First Nation, Dease River Band Council or Liard Aboriginal Women's Society. These entities are responsible for the accounting and administering the funds on your behalf.
